COMMITTEE REPORTS

Landscape Committee

Various removals & replacements were approved. Crabapple Tree Replacement removals for FY 19/20 have been removed, replacement will take place in Spring 2020.

Kat Irvin would like the Committee to discuss grub problems & solutions. Also, pine trees bordering Parkwood & Washtenaw seem to be dying.



M&M Committee

Minutes submitted and reviewed. The committee did not have quorum at the September meeting.

Governing Documents Amendment

On-going. This needs to be budgeted for in upcoming fiscal year(s). The Co-op leasing restriction needs to be removed to begin FHA approval process.

City of Ann Arbor Snow Removal Agreement

Margolis is compliant. We have sent our documents for review/compliance. Waiting for City of Ann Arbor's legal team to review insurance.

City of Ann Arbor Trash Cart Swap

Completed. Thirty-two residents participated in the exchange.

Egress Window Specification

Verbiage revised throughout specification to read "if issue is found, the issue must be corrected by the co-owner regardless if the co-owner decides to proceed the egress window installation. "John would like to see the cost specified somewhere in the specs. Kat motioned to approve the specifications with the revised verbiage. Motion seconded by Leif. John voted not in favor/no. Motion carries.

Storm Door Specifications

21-SS model does not fit architecturally/aesthetically in the community. John suggested sending it back to the M & M Committee for review.

Trash Can Enclosure Specification

This went back to M & M Committee but was not reviewed at October meeting because they did not have quorum.



NEW BUSINESS

Fiscal Year 2020-2021

It's early in the process, but committees will discuss their numbers beginning in November. Jessica would like them to be as frugal as possible. We must keep in mind the electrical issue/project/insurance and how this affects our bottom line/monthly fees.
