City of Ann Arbor Snow Agreement – we now have our new insurance certificate and will begin the approval process again for the next winter season.

FHA Approval – will be discussed at the Annual meeting and be considered when we revise our bylaws.

Long Term Planning/Reserve Study To-Dos

Jessica is suggesting that the roof analysis be a tool for planning.

We need to be aligned on the big key items that we want to plan and save for.

We need to help drive the reserve study which we have already approved to be done.

This should help us get a more accurate reserve study.

We should set up another meeting to further discuss this – May 10th at 1:30 pm.

Landscape Committee Response to Board Regarding Milkweed Finalization. Discussion

Pollinator plants have been planted in each corner bed.

The only plants Monarchs will lay their eggs on is milkweed.

The committee is very concerned of the ramifications of allowing any milkweed plants being allowed in PV.

Should we revisit the policy? If we had to vote again on this, John would strongly vote no. this needs to be resolved and finalized or communicated to the association. Brian and John will assist Kendra with a cover letter to go along with the Do Not Plant List.
