A Word from the Board on DTE Smart Meters

There was some discussion at the annual meeting about resident concerns about "smart Meter" installation, timing of installation, and the question of DTE offering an "opt out" at some point in the future, but much of the information remains unclear. In April we starting to hear from a few residents with concerns, so our property manager (Melissa) contacted our City Council representative, Chris Taylor for information and guidance.

Mr. Taylor explained that the City has not had involvement in the meter conversions, but suggested that the regional manager for DTE (Paul M. Ganz) has been helpful to City residents when DTE-related issues arise. Melissa communicated with Mr. Ganz and he confirmed for us that he is open to residents contacting him directly with questions or concerns. His contact information is as follows:
