# **Board Beat: Midsummer Report**

July has come and gone, summer's already halfway through, and the affairs of Village governance continue steaming right along. On the very last day of July the Board met and took up mostly routine matters.

• Open Forum: Plans for Pittsfield Boulevard. Residents Michael and Sheryl Wytychak came before the Board to voice two important concerns. Sheryl expressed the hope that as part of the roads renewal work to be carried out here by the City over the next two to three years, traffic calming measures could be incorporated into the design of our central thoroughfare, Pittsfield Boulevard. Drivers routinely race along this road, often ignoring stop signs and frequently careening the wrong way through the traffic circle.



Michael raised a different but related issue: the new designated *bike corridor* mandated by the City for Pittsfield Boulevard between Edgewood and Washtenaw. This is included in the to-do list for the Pittsfield Village Improvements project currently in the design and planning stages. He like so many of us who are aware of the City's intent here is concerned about the form such a bike path might take, given the constraints of parking on both sides of the street and heavy auto and truck traffic there throughout the day.

We will make certain that both issues are raised at the Public Informational Meeting to be held by OHM and the City on Thursday, August 15, at the Pittsfield School.



"Leave the Leaves" Program: Prior to the meeting, Erin Brightwell had circulated a draft proposal for implementing this pilot program in the coming fall and winter. Board members had many questions. After some discussion the matter was put on hold and it was decided that members would collect their thoughts and forward comments and recommendations to Erin and her group over the next week or so. Erin will then return at the August meeting with a revised addresses Board concerns. that Assuming the revised plan meets with Board approval, implementation will then move forward.

• Expensive Repairs. Breaks in service lines connecting three units of a four-plex on Richard to the sanitary sewer main will require expensive excavation and new plumbing at a cost of more than \$16,000 over the next couple of months. Then there is a major rescue operation to mount at an end unit on Fernwood: 13 helical piers must be installed to level and support the crawl space foundation walls. Excavation around that portion of the unit will require removal of all

landscaping and destruction of the owner's deck. Cost to the Association: \$26,000 to the contractor, regrading as fill settles over the next year, and replacement of plantings. Cost to the owner: installation of a new deck.

Our buildings are all close to 80 years old, we've been making similar repairs in other units over the past several years, and it seems likely that there will be many more to come. This is what the capital budget and reserve fund are for. This is where a large portion of our monthly fees are spent. With the multi-year re-roofing and attic insulation program coming to an end this fiscal year, we'd love to transition to new doors and windows.

It's a hard reality to face, but highly likely that such above-ground improvements will be required to yield to below-ground repair work for many years to come. In just one month the Board has been compelled to dedicate more than \$40,000 on just 4 of our 419 homes.



• Specifications Review. The Maintenance and Modification Committee had forwarded two new specifications for review and approval by the Board. Both were tabled: (1) a spec for installing a whole-house back-up generator and (2) a spec for installing pavers around a front trash cart enclosure. Outside generators are not presently permitted under the provisions of our master deed. The Board voted to refer this to our law firm for an opinion. As to the pavers, the Board postponed action so that members could visit and view for themselves an installation permitted by the M&M Committee as a "test case." There are concerns about such additions and their potential to detract from the curb appeal of our buildings. Both proposed specs will likely come up again for action at a future Board meeting.

#### Other Actions.

In a unanimous vote the Board formalized its decision to decline the City's offer to install water meters in each of our units. Our cost for doing so would have exceeded \$860,000. Instead, under the plan we've opted for, the City will bear all metering costs: one meter for every two units.

- Michigan "Homeowners' Energy Policy Act." This recently enacted legislation compels "Homeowners' Associations" and certain condominium associations to allow members to install a variety of energy-saving devices. Our legal counsel have been asked to advise us on our compliance responsibilities—if any—under this new law. We already make provision for members to install most every one of the devices listed in the act. Clotheslines and rain barrels are the exception. Meanwhile, the Go-Doc Committee has included removal of the Bylaws prohibition on clotheslines and, along with many other updates to our governing documents, that should go before members for a vote later this year or early next. As to rain barrels, those are still subject to debate; as of now they are not allowed.
- *Pool Rules.* Revisions are in the works.
- **Property Ownership.** OHM and the City have asked for our help in determining ownership of a parcel of land at the rear of the Pittsfield School ballfield. Though not included in our master deed as drawn at the condo conversion in 2009, the land may nonetheless belong to us, as that is how it was shown in the original plat from the 1940's. The schools do not believe it to be theirs. We have asked our legal counsel to investigate. The City and OHM will also continue their searches. The city would like to construct a storm water overflow reservoir there and will need an easement from the owner—whoever that may be.



# Public Meeting: "Pittsfield Village Improvements Project"

The City and project engineering firm OHM will hold the first of a planned series of public informational meetings about the massive infrastructure overhaul coming to our community during the next two to three years. *Date:* Thursday, August 15. *Time:* 6:00-8:00 pm. *Place:* Pittsfield School.

A quick summary of things to come: (1) new water mains and meters for every two units, (2) greatly enlarged and improved storm water handling system, (3) overhauled sanitary sewer system, (4) repaved—and in some places—reconstructed roads, (5) designated bike corridor along Pittsfield between Edgewood and Washtenaw.

Over the past many months I have written extensively about all elements of this project. In preparation for the meeting I invite you to review those articles, beginning with my first write-up back in November 2023 after City Council voted to move forward with the project. # SOME COMMON WEEDS OF AUGUST

# 1. Nutsedge



Nutsedge spreads by underground structures called rhizomes and nutlets. They also spread by seed, making it very difficult to control. This weed can take over lawns and landscape beds, intertwining themselves with desirable plants.



# 2. Common Lambsquarter

This common weed can harbor viruses that can affect your desirable plants. They don't spread as easily as some other weeds but still should remain out of your landscape beds.



# 3. Eastern Black Nightshade

Invasive? Yes! Eastern Black Nightshade's root system is fibrous and extensively branched. It's like the plant's underground support network, anchoring it firmly and efficiently drawing nutrients and water. This weed is adaptable too. Thriving in various conditions and spreading more by its berries.







# **Poison Ivy**

Poison ivy grows quickly and propagates itself by underground rhizomes and seeds. Seeds are quickly spread by birds and other animals that eat the small fruits. Poison ivy can get started in the landscape from a seed dropped by a bird and may quickly become a widespread problem. It often grows in shrubs and groundcovers, making it difficult to control.


